Legislative Corner Lt Col Gerald W. (Jerry) Haynes, USAF-Ret



This month we take a look at the latest "uniform" policy change.

The Pentagon has relaxed its rules governing what "religious" apparel and facial hair troops can wear or maintain while in uniform. This includes in some cases, permitting tattoos, body piercings and other religious items. The Defense Department, on 22 January 2014, issued the changes as part of its changing approach to making religious accommodations. The new policy will allow service members to sport different kinds of religious garb and hairstyles so long as they don't have an "adverse effect on military readiness." mission accomplishment, unit cohesion, and good order and discipline." Immediate commanders will be allowed to grant accommodations to service members in some cases but in others they will have to be approved at a higher level. The changes create several new categories, besides clothing, of religion-based features that can be displayed by troops. In fact, they now include facial hair, such as beards, and religious tattoos and piercings. The pentagon did stress that religious apparel that "impairs" the safe operation of weapons, poses safety hazards to others, or interferes with special equipment like helmets or flak jackets won't be permitted. A DoD spokesman says that the Department places a high value on rights of members of the Military Services to observe the tenets of their respective religions and the rights of others to their own religious beliefs, including the right to hold no beliefs." Each individual service member has to re-apply for new permission at each new assignment, transfer of duty stations, and for each deployment.

While this initially appeared to be a Pentagon policy change, it was subsequently reported to have been directed by Congress. What do you think?

Offset Sequestration Cuts by Trimming Social Security and Reducing COLA adjustments?

Two House lawmakers are putting forth legislation to ease sequestration cuts for defense by trimming Social Security benefits and boosting some Medicare premiums. The bill by these two representatives would in part, alter how cost of living adjustments are determined for Social Security in order to offset defense cuts for 2014 and 2015. The idea is this would bring the deficit \$200 billion below its current baseline. There was a similar situation with the country's budget nineteen years ago when the military took a pay cut and Congress then gave themselves a pay raise. It's time for all real Americans to begin voting for changes in the selection of Congressional Representatives. Out with the old and in with the NEW. (How about all current and retired Congress personnel take a reduction in pay and retirement?)

This recent passage of the Bipartisan Budget Act (BBA) was trumpeted as a bipartisan, two-year, sequestration-alleviating budget deal. But, in reality,



Increased TRICARE Beneficiary Use of Online and Phone Customer Service Leads to End of Walk-in Service as of April 1, 2014

Keeping up with the rapidly increasing number of TRICARE beneficiaries who most often turn to a laptop or cell phone when they have questions, walk in service at the Fox Army Health Center's TRICARE Service Center (TSC) will no longer be available as of April 1, 2014. Find out more at www.tricare.mil/TSC.

Fox Army Health Center patients still have a wide variety of secure, electronic customer service options available through www.tricare.mil. The new "I want to...." feature puts everything beneficiaries want to do online right on the front page of www.tricare.mil.

When walk-in service ends April 1, beneficiaries can obtain personal assistance by calling Humana Military for enrollment and benefit help at 1-800-444-5445. All health care, pharmacy, dental and claims contact information is located at www.tricare.mil/contactus. Beneficiaries can get 24/7 TRICARE benefit information at www.tricare.mil, and make enrollment and primary care manager changes, and more online at www.tricare.mil/enrollment

Rather than driving to an installation TSC, TRICARE beneficiaries can even combine high-tech with low-tech by downloading health care forms online and sending them in the old fashion way, through the U.S. mail – at a cost of less than 50 cents.

Walk-in customer service is also the most expensive possible customer service option. By eliminating walk-in customer service at TSCs, the Department of Defense estimates savings of approximately \$250 million over five years. The change does not affect TRICARE benefits or health care delivery.

the budget deal was another backroom, eleventh-hour deal rushed through both the House and Senate before the holidays, bypassing the committees of jurisdiction and highlighting a growing military/civilian divide that fails to recognize the necessary sacrifice that comes with 20 years of service. Even though the budget deal would help ease the harmful effects of sequestration for two years for the Pentagon, doing so on the backs of service members who serve our nation for more than two decades is a disgraceful way of doing it.

Fortunately, several other members of Congress--now that they have seen the harmful effect of the change -- have introduced more than 17 bills to repeal some or all of the COLA provision.

But, there are still critics, including many members of the press, who are supporting the COLA cut. They are calling it exceedingly modest to "a military pension plan that is already far more generous than private-sector equivalents." What has caused these critics to believe the military pension is out of line?

Well, it started when our own uniformed and civilian leaders within the Pentagon created the perfect storm, providing political top cover to slash pay and benefits with their repeated, alarming, and false claims about "exploding" personnel cost growth. The Pentagon's current rhetoric on exploding personnel growth has emboldened some of those in the Congress to consider making drastic changes to the military benefits, compensation, and retirement system in the name of fiscal responsibility. They are doing this without fully understanding the unintended consequences of their actions, the immediate impact on morale, and subsequent effect on retention.

The press, and the American people and the Congress should not take for granted the sacrifice and service (and retention) of our all-volunteer force by equating it to civilian careers. Fox Army Health Center Enters Final Phase of HVAC System Renovations

Effective 22 January 2014, the Clinic will be entering phase eight of our HVAC System Repair & Renewal Renovations. This is the final phase of the project which has provided our facility, staff and beneficiaries with better air quality and air flow.

During Phase eight, the Laboratory, and Redstone Dental Clinic will be relocated to the Transition Building, located in the parking lot at the east side of the building. cheap," and equating the benefit package to those in the civilian workplace devalues and trivializes the very nature of career service in uniform. The men and women in uniform cannot say "No!" when presented with orders they don't like. They, unlike civilians, are subject to the Uniform Code of Military Justice. And in order to earn the retirement benefit, service members must make it through an 'up-or-out' personnel system or potentially face being separated or discharged. The entire military family makes tremendous sacrifices on the road to potential retirement. Military spouses seldom establish their own careers because of frequent and involuntary separations and relocations, and because of frequent moves, military couples rarely spend enough time in one place to gain any equity in a home. Military children, on average, will attend six to eight schools during grades K-12. Their young lives are also peppered with extended separations from their military parent. Along the road to retirement, many will decide the personal sacrifice is too great. And some critics are the first to point out military retirees leave in the 40s or 50s and immediately find gainful employment. But not all military skills translate well into civilian jobs, regardless of what some pundits say. And the reality is two incomes are necessary to reach the standard of living to maintain a household and send their kids to college.

But what is most disturbing is equating military service to the private sector. We've seen the service and sacrifice our men and women in uniform and their families have had to endure over the past 12 years of war — and they are far from civilian-like. The Chairman of the Joint Chiefs of Staff Gen. Martin Dempsey, USA, stated in a hearing before the House Armed Services Committee in October 2011 that the military retirement program "needs to be fundamentally different than anything you can find in the civilian sector." **The bottom line is that,...** "until you can adjust the conditions of service for those in uniform to be more 'civilian-like,' stop trying to compare the two.
