"All politics is local."

A proposal in a December 2022 Congressional Budget Office (CBO) report suggesting the reduction or elimination of VA disability payments for veterans with higher incomes received significant attention on social media in recent weeks—enough that it was raised, and rebuked, during VA Secretary Denis McDonough's press conference March 23.

As MOAA outlined shortly after the report was released, the CBO options include potential cuts to military spending, veterans' benefits, and TRICARE. The report, filed at the start of each new Congress for the past 12 years, provides lawmakers with options to reduce the deficit through spending cuts and ways to increase revenue. The nonpartisan CBO has no say in political objectives and is simply fulfilling its mandated mission via these reports. While the notion of meanstesting VA disability pay is concerning, no legislation to that effect has been offered in either chamber, or has the proposal been a part of any administration budget plans.

As Members return, staff will brief their bosses on key developments from the past two weeks and forecast what the next few days on Capitol Hill hold in store. Some of the issues.

The House Rules Committee will meet this afternoon to prep two bills for House floor consideration, one of which is H.R. 734, the "Protection of Women and Girls in Sports Act of 2023." Of note, this is the House companion to a bill introduced by Alabama Senator Tommy Tuberville. The Bill would ensure Title IX provisions treat gender as "based solely on a person's reproductive biology and genetics at birth," and would ban "recipients of federal funding from operating, sponsoring, or facilitating athletic programs that permit a male to participate in a women's sporting event."

The U.S. government has exceeded its statutory authority to borrow money to pay its debts, and the temporary "extraordinary measures" currently utilized by the Treasury Department will expire sometime between June and September. Reports suggest that House Republicans are compiling a legislative package to raise the debt ceiling but cap discretionary spending and effectuate several other conservative cost-saving cuts. None of this is anywhere close to final. The big question continues to be whether the defense budget, which represents about half of discretionary spending, will ultimately be on the chopping block. In congressional negotiations, early legislative proposals are often intended as markers to stake out a position, put members on record, and, in this case, jumpstart talks with the White House.

As of June 5, 2023, FAHC will expand clinic & pharmacy hours to 0730 – 1600, Monday - Friday.

Fox Army Health Center has transitioned to a new electronic health record (EHR), MHS Genesis, to help streamline and standardize patient record keeping. We "went live" on 24 September. As we acclimate to using the new EHR, patients will experience longer than normal wait times for appointments in clinical services and pharmacy. To minimize wait times, we encourage using one of these alternative options for receiving same day care:

- TRICARE Nurse Advice Line
- Network Urgent Care Center
- Doctor on Demand
- Emergency Department

Follow these best practices to obtain your prescriptions during the MHS Genesis transition:

- For all medications, you MUST "activate" your prescription ahead of time to give the pharmacy time to prepare your medicine. Same day filling is not available.
- The FAHC phone extension x1030 will no longer be available. You will not be able to leave a voice message.
- All new or renewed prescriptions will need to be requested through the FAHC website, then click on either the PCRS or the MHS Genesis Patient Portal icon to activate the prescription. Link to the Fox Website: https://redstone.tricare.mil/health-services/pharmacy
- For refills, use the automated refill phone line to activate: 256-842-7337

Fox Optometry Clinic provides primary care vision services including comprehensive ocular health exams to all beneficiaries (Active Duty, Active-Duty Family Members, Retirees and their family members. Call the main appointment line, 256-955-8888 option 2.

The FAHC Laboratory is closing at 1300 daily.

Surviving Spouse Corner: Tax Time Considerations

Note: Even though the tax filing date has passed, these are some good ideas for your consideration. Always consult a tax professional for your specific financial situation.

If you have already filed your 2022 taxes, bravo! Some have not. Some are procrastinating. Others might have been receiving documents through mid-March, depending on investments held, and are just beginning the process. Please review your documents carefully, and make sure that information is correct. If not, ask for a correction before you file.

The deadline for filing 2022 taxes is April 18, 2023. You may file an automatic extension, but taxes are due on the April date. Don't wait to file until the extended due date; file as quickly as you can. A relocation, an illness, or a family death could happen to you or your preparer (consultant) in that time frame and create more complications.

Here are some issues and information for your consideration:

- Look for changes in the first few pages of instruction publications of the IRS forms and schedules that have been used in other years to report your income. Find them at <u>www.irs.gov/forms-instructions</u>. For example, some of the changes mentioned in the Form 1040 2022 include Clean Vehicle Tax Credits, Residential Home Improvement Energy Credits, and Increases in Standard Deductions.
- If you changed jobs in 2022, make sure you have not overpaid the FICA withholding.
- If your spouse died in 2022, you can still file 2022 taxes as married as long as you have not remarried in 2022. But next year, 2023, you must file as single if you have not remarried or have no dependents. This can cause tax consequences you should consider and prepare for. For example, a lower single income is taxed at a higher rate than married income. If your spouse was the higher income earner, there will be a change in tax owed, but it might be a manageable increase, or it could be less. If you are the higher income earner, you will have a lower standard deduction, and you might pay taxes at a higher rate.

If you have overpaid taxes this year, you may apply the refund to 2023 taxes. If you are required to make estimated payments, the overage might save a quarter filing of the estimated tax for 2023. You can also ask for a refund to place in savings until next year. Also, if you need to convert an investment to cash, be aware of the tax consequences.

Possibly your spouse always did the tax filings, and this is new to you. If you are overwhelmed, get help. If a mistake is made or some income or deduction is overlooked, you can always file an amended return. Try to file by April 18.

Acts 15: 36-40

36 After some days Paul said to Barnabas, 'Come, let us return and visit the believers in every city where we proclaimed the word of the Lord and see how they are doing.' ³⁷Barnabas wanted to take with them John called Mark. ³⁸But Paul decided not to take with them one who had deserted them in Pamphylia and had not accompanied them in the work. ³⁹The disagreement became so sharp that they parted company; Barnabas took Mark with him and sailed away to Cyprus. ⁴⁰But Paul chose Silas and set out, the believers commending him to the grace of the Lord.

Welcome to May, hoping for flowers that April showers are said to bring. April brought us the celebration of Easter, maybe more aptly known as Resurrection Day. For many, this means new life. As we celebrate new life while admiring the flowers, we sometimes tend to disagree on how to take care of them. How much light do the flowers need, how often should I fertilize, and maybe how often do I need to water? Failure on any of these can result in the dying of those beautiful flowers. Gov. Kay Ivey has released her budget requests for FY 2024, including a proposal for a 2 percent raise for all state employees. Lawmakers will take the governor's proposals as a starting point and pass the budgets sometime over the next several weeks.

For the General Fund budget, which pays for non-education programs, Ivey requested \$2.97 billion in spending, which is \$230 million more than this year, an 8.4 percent increase. It would be the largest General Fund budget ever, which was expected because of an unusually large increase in the tax revenues that support the budget. The proposal is for the fiscal year 2024.

The agencies that receive the largest amounts from the General Fund every year, the Alabama Medicaid Agency and the Alabama Department of Corrections, would both receive substantial increases in Ivey's proposed budget. Medicaid would get an increase of 9 percent, to \$863 million. The ADOC would get an increase of 10 percent, to \$662 million.

Among the other allotments in Ivey's proposed supplemental spending bill:

- **\$43 million** to the Department of Mental Health. Of that, \$23 million would be for construction costs at Taylor Hardin Secure Medical Facility, the psychiatric hospital for criminally committed male patients; \$10 million would be for the reopening of Pickens County Hospital and renovations for child and psychiatric services; and \$10 million would be for renovations at East Alabama Medical Center for child and psychiatric services.
- **\$12 million** to the Alabama Forestry Commission, including \$10 million for grants to volunteer fire departments and rescue squads and \$2 million to replace firefighting equipment.
- **\$8 million** for elevator upgrades in the State Capitol.
- **\$8 million** for the AL Law Enforcement Agency for the computerized criminal history system.
- **\$5.7 million** to the Military Department for construction costs at the Huntsville Armory.
- **\$5 million** for repairs and maintenance at the surplus property warehouse of the Alabama Department of Economic and Community Affairs in Montgomery.
- **\$4.8 million** to the Department of Forensic Sciences, including \$4 million for equipment in the Huntsville lab and \$800,000 for equipment in the new Dothan lab.
- **\$1.9 million** for repairs at the Heflin-Torbert state judicial building in Montgomery.

The following legislative actions are Law:

• Those convicted with possession of 1-2 grams of fentanyl be given a mandatory three-year sentence; ten years for 2-4 grams, 25 years for 4-8 grams, and a life sentence for eight or more grams.

The following legislative actions well may be signed by Governor Ivey, are not Law yet:

- A Bill that would prohibit a list of what it calls "divisive concepts," or ideas that people from any one group should be asked to accept "a sense of guilt" because of their race or gender—or that fault, blame, or bias should be assigned to a race or gender solely because of their race or gender. The House State Government Committee approved the bill on a 9-3 vote, so it now moves to the full House of Representatives. Republicans in several states have proposed restricting how race and gender are taught in classrooms and diversity training sessions for state workers. Rep. Ed Oliver, the bill's sponsor, told the committee that the bill is needed because people are concerned about racist ideas and what he said are "woke policies" taught to children.
- A Bill that would increase penalties for felonies committed during gang activity, create a minimum sentence for any use of a firearm by gang members and specify people 16 and older can be charged as adults for gang-related offenses. Under existing law, juveniles 16 years of age or older are only tried as

Get Advice from a Nurse 24/7

With the coming of spring, the temperatures warm and the tempo of life picks up. Outdoor activities resume recreation, yardwork, cookouts—and change of station plans swing into high gear. Amid the busyness of these warmer months, the potential for minor injuries and health concerns may increase. It's good to know that you have all-the-time access to health information and advice via the Military Health System Nurse Advice Line.

Here are answers to some commonly asked questions about the MHS Nurse Advice Line.

Q: Who's eligible to use the MHS Nurse Advice Line?

A: You can use the MHS Nurse Advice Line if you're a TRICARE beneficiary living or traveling in the U.S. or in a country outside the U.S. with a military hospital or clinic. This includes:

- Active duty service members
- Active duty family members
- Retirees and their family members

It's important that your sponsor's and your family members' personal information is up to date in the Defense Enrollment Eligibility Reporting System. Log in to milConnect to check your information to ensure it's current.

If you're enrolled in the US Family Health Plan, you can't use the MHS Nurse Advice Line.

Q: What kind of help can I expect?

A: When you call the MHS Nurse Advice Line, you'll be connected to a registered nurse. They'll help you identify illness and safely treat minor injuries. If your condition is urgent or serious, they'll help you find the urgent care or emergency care you need.

Your nurse can:

- Answer your health care questions
- Assess your symptoms and give recommendations for the most appropriate steps to take
- Provide instructions to treat minor issues or self-care tips that you can use at home
- Help locate the closest urgent care or emergency care facility, if necessary
- Help you schedule and appointment at a military hospital or clinic, if you're enrolled

Q: What types of questions or advice can I call with?

A: Here are a few examples:

- I have a rash after working in the yard—how should I treat it?
- When should I take my child to the emergency room if their fever doesn't come down?
- I think I sprained my ankle, but I'm not sure if I should get it X-rayed. How can I tell the difference between a cold or a sinus infection?
- Our child fell off his bike and hit his head—should we take him to the hospital to check for concussion? We need medical care, and we aren't near a military hospital or clinic. Where should we go?

Q: How can I connect with a nurse?

A: Nurses (including pediatric nurses) at the MHS Nurse Advice Line are available 24/7 by phone, online chat, or video chat. Follow these steps to use the MHS Nurse Advice Line:

- Go to the MHS Nurse Advice Line website
- Choose call, chat, or video chat

If you you're in the U.S., Guam, or Puerto Rico, call 1-800-TRICARE (1-800-874-2273) and choose option 1. Outside these countries, go to the MHS Nurse Advice Line website to find your location-specific number.

Q: Can I use the MHS Nurse Advice Line if I live or I'm traveling overseas?

A: The MHS Nurse Advice Line is available overseas where there's a military hospital or clinic. If you're traveling overseas and need care outside of the MHS, you can call the MHS Nurse Advice Line. A nurse will coordinate with the TRICARE Overseas contractor to get you the care you need.

Q: In an emergency, should I call the MHS Nurse Advice Line?

A: No. The MHS Nurse Advice Line isn't for emergency situations (conditions that threaten your life, limb, eyesight, or safety). If you or a family member reasonably believe you're experiencing a health emergency, dial 911 or go to the nearest emergency room. If overseas, dial your international emergency number.

The MHS Nurse Advice Line is there for you all year round, day or night. Whether you're in your own backyard or moving across the country, a nurse is available when you need health care advice, nonemergency treatment, and options for care after hours.



Memorial Day

Memorial Day is an American holiday, observed on the last Monday of May, honoring the men and women who died while serving in the U.S. military. Memorial Day 2023 will occur on Monday, May 29.

Originally known as Decoration Day, it originated in the years following the Civil War and became an official federal holiday in 1971. Many Americans observe Memorial Day by visiting cemeteries or memorials, holding family gatherings and participating in parades. Unofficially, it marks the beginning of the summer season.

The Birthplace of Memorial Day and Early Observances

The Civil War, which ended in the spring of 1865, claimed more lives than any conflict in U.S. history and required the establishment of the country's first national cemeteries.

By the late 1860s, Americans in various towns and cities had begun holding springtime tributes to these countless fallen soldiers, decorating their graves with flowers and reciting prayers.

Waterloo—which first celebrated the day on May 5, 1866—was chosen because it hosted an annual, community-wide event, during which businesses closed and residents decorated the graves of soldiers with flowers and flags.

Did you know? Each year on Memorial Day a national moment of remembrance takes place at 3:00 p.m. local time.

Decoration Day

On May 5, 1868, General John A. Logan, leader of an organization for Northern Civil War veterans, called for a nationwide day of remembrance later that month. "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land," he proclaimed.

The date of Decoration Day, as he called it, was chosen because it wasn't the anniversary of any particular battle.

On the first Decoration Day, General James Garfield made a speech at Arlington National Cemetery, and 5,000 participants decorated the graves of the 20,000 Civil War soldiers buried there.

Many Northern states held similar commemorative events and reprised the tradition in subsequent years; by 1890 each one had made Decoration Day an official state holiday. Southern states, on the other hand, continued to honor the dead-on separate days until after World War I.

History of Memorial Day

Memorial Day, as Decoration Day gradually came to be known, originally honored only those lost

while fighting in the Civil War. But during World War I the United States found itself embroiled in another major conflict, and the holiday evolved to commemorate American military personnel who died in all wars, including World War II, The Vietnam War, The Korean War and the wars in Iraq and Afghanistan.

For decades, Memorial Day continued to be observed on May 30, the date General Logan had selected for the first Decoration Day. But in 1968, Congress passed the Uniform Monday Holiday Act, which established Memorial Day as the last Monday in May in order to create a three-day weekend for federal employees. The change went into effect in 1971. The same law also declared Memorial Day a federal holiday.

Memorial Day Traditions and Rituals

Cities and towns across the United States host Memorial Day parades each year, often incorporating military personnel and members of veterans' organizations. Some of the largest parades take place in Chicago, New York and Washington, D.C.

Americans also observe Memorial Day by visiting cemeteries and memorials. Some people wear a red poppy in remembrance of those fallen in war—a tradition that began with a World War I poem. On a less somber note, many people take weekend trips or throw parties and barbecues on the holiday, perhaps because Memorial Day weekend—the long weekend comprising the Saturday and Sunday before Memorial Day and Memorial Day itself—unofficially marks the beginning of summer.

adults for certain crimes. This act would require these individuals to be tried as adults for any gangrelated criminal activity. The Alabama Association of Chiefs of Police and the Alabama Sheriffs Association submitted a letter for this legislative action. More than 160 sheriffs and police chiefs signed the letter.

- A Bill that would permit licensed social workers in Alabama to diagnose and develop treatment plans for patients passed the Alabama House Tuesday. This Bill would help expand health care reach in the state particularly those in more rural areas by permitting social workers to diagnose patients remotely through telehealth communications.
- A Bill in the Alabama Senate that would allow retired law enforcement officers to earn more money working as school resource officers without affecting their state-run retirements. Currently, retirees in the Retirement Systems of Alabama can earn \$37,000 from an employer who participates in RSA without having to suspend their retirement benefits.
- The Alabama Legislature has expanded occupational licensing reciprocity for military spouses and dependents every year since 2018. Rep. Kenneth Paschal, R-Pelham, says he is continuing to make Alabama a military friendly state by sponsoring legislation that will allow military personnel and military dependents licensed as cosmetologists in other states to continue practicing their trade while stationed in Alabama.
- A Bill that would require cameras in classes in which at least half of the students receive special education services. According to the bill, the video cameras would record audio and video during school hours and at any time a student is present. Recording must be kept for at least three months.
- A Bill that will prohibit Transgender women in Alabama would from joining female sports teams in college'. The House voted 83-5 in favor of the legislation that would extend a 2021 ban on transgender athletes in K-12 sports teams to include college teams. The bill states that sports teams "designated for females, women, or girls shall not be open to a biological male." Similarly, a "biological female" would also not be allowed to participate on teams for boys and men. The legislation now moves to the Alabama Senate.

And there are several Bills looking to reduce the State of Alabama's tax on groceries and/or a potential rebate of state income tax.

The March 2023 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), released April 12, was 296.021, 1.4% above the FY 2023 baseline of 291.901. The next CPI-W release is set for May 10. The CPI-W figures from the end of this fiscal year (July, August, and September 2023) will be compared to the FY 2023 COLA baseline to calculate the 2024 COLA.
