"All politics is local."

As reported in last month's article, a new collaboration between the Alabama Departments of Veterans Affairs and Mental Health has officially kicked off, aiming to see the agencies work together to improve both quality and access of mental and behavioral health care resources for veterans. It's the result of Senate Bill 135, sponsored by Sen. Andrew Jones, R-Centre, the chair of the Senate Committee on Veterans and Military Affairs, which went into effect on June 1.

The head of the Alabama Department of Veterans Affairs has filed an ethics complaint against the leader of the Alabama Department of Mental Health. The ethics complaint was reported late last week by <u>Lagniappe</u> in Mobile. The newspaper received a leaked copy of the complaint that alleges ADMH Commissioner Kim Boswell "colluded" with other state officials to keep the veterans affairs department from getting about \$7 million in American Rescue Plan Act funds.

The complaint, a copy of which Alabama Daily News later obtained, also accuses Boswell and lobbyists of trying to "kill" a bill to create a state-run system of mental health care for veterans. A lesser version of the bill became law this spring. The complaint was written and submitted by ADVA Commissioner Kent Davis. At the center of it is John Kilpatrick, a Mobile-based veterans care provider who was seeking funding for his Vets Recover clinic. He's also on the State Board of Veterans Affairs that oversees the department and the commissioner.

According to the complaint, Kilpatrick was critical of the mental health department in a Feb. 12 presentation before the Opioid Settlement Oversight Committee, a panel of lawmakers and other state leaders helping to direct hundreds of millions of dollars in settlement funds. Kilpatrick was seeking some of that funding. The complaint accuses Boswell of undoing an MOU between the two departments involving \$7 million in federal funding for non-profit organizations and colleges to provide services to the military and veteran community.



Fox Army Health Center MAJ Bruce T. Robinson, USA-Ret



The Birmingham VA Health Care System and Fox Army Health Center announced a strategic sharing agreement aimed at enhancing health care services for Veterans and military personnel in the Huntsville region. This partnership underscores our shared commitment to providing high-quality medical care to those who have served our country.

Under this agreement, Fox Army Health Center will have access to the Huntsville Veterans Clinic's advanced MRI / CT imaging, and Ultrasound / Screening Mammography procedures. The Huntsville Clinic will utilize space at Fox Army Health Center to establish a full Patient Aligned Care Team (PACT), offering comprehensive primary care services for Veterans. This collaboration is expected to expand VA's capacity to serve nearly 1,300 additional patients at the Fox Army location.

On August 7, 2024, the Birmingham VA and Fox Army Health Center made the partnership official with a ribbon-cutting ceremony, marking the commencement of the new sharing agreement to enhance health care services in Huntsville.

"We are honored to enter into this partnership with Fox Army Health Center," said Oladipo "Ladi" Kukoyi, CEO/Executive Director of the Birmingham VA Health Care System. "This collaboration represents a significant step forward in our ongoing efforts to provide Veterans and military personnel with the best possible health care. By combining our strengths, we can offer more comprehensive and accessible services to those who have bravely served our nation." Kukoyi added, "This agreement adds an extra layer to the patient experience."

"We are excited about the opportunities this partnership will create and look forward to working closely with the Huntsville Clinic and Birmingham VA," said Lieutenant Colonel Deepak Mathew, Fox Army Health Center Commander. "In many cases the Veteran might be eligible for care at the DoD level and the VA level. In these instances, the patient will have everything as a 'one-stop' shop with both primary care and the pharmacy in a single location. But the main goal is to improve the health and well-being of our Veteran and military community."

The primary goals of this initiative include: Expanding Access to Care: Veterans and military personnel will benefit from increased access to MRI and CT imaging and Ultrasound and Mammography services at the Huntsville VA, while also receiving primary care from a dedicated PACT team at Fox Army Health Center. Improving Quality of Care: By pooling collective expertise and resources, VA and Fox Army aim to enhance the quality and efficiency of medical care provided to Veterans and military personnel.

Fox is having a flag laying ceremony for Suicide Prevention Awareness month on September 9 at 7:30 AM. LTC Mathew will speak and plant the first flag at 7:30, Fox employees, guests, and visitors are welcome to participate.

The Heroes Café at Fox is open for breakfast and lunch. The grand opening will be 11 AM. on September 9. Open hours are 7:30 AM to 2 PM. Breakfast is served from 7:30 to 9:30 and lunch from 10:30 to 2 PM. Grab n Go items are available all day.



Surviving Spouse Corner: Who Is Best to Serve as an Executor?

One of the many important decisions when making an estate plan is whom to trust to be the executor (of the will) of the deceased's estate. Usually, the executor is named in the last will and testament and is likely the surviving spouse, adult child, a trusted family member, or a trusted friend. Sometimes the executor is an attorney, bank officer, or other impartial agent.

The person named for this important role should be asked if they are willing to assume responsibility and if they understand what the duty entails and what they will be responsible for when the time comes. The duty of executor can be a very complicated and time-consuming role, and no one should be "surprised" to learn they are the executor of an estate. The executor has a legal duty to act primarily for the benefit of another with duties involving good faith, trust, special confidence, and candor.

Many times, married couples just assume their spouse will be the executor of the estate, and that spouse might have no idea of the complexities and requirements, which can vary from state to state. A person who manages money or property for the deceased must exercise a standard of care as imposed by law or contract with specific responsibilities.

The administration of an estate generally requires a fair amount of time and energy. Often compensation is allowed, and a court or commissioner of accounts must approve the compensation, which is often a percentage of the assets handled.

Some other duties of an executor include:

- Understand the rules of probate (the official proving and recording of the will as the authentic and valid last will and testament of the deceased).
- Know which asset types that do and do not pass through probate.
- Keep assets under control as a fiduciary, separate from individual, personal and business assets.
- Prepare a complete inventory of all assets in the estate (stocks, bonds, brokerage accounts, bank accounts, life insurance policies, real property, automobiles, and any other assets). Having a complete and accurate inventory of the assets enables the executor to properly manage the estate and satisfy all of the terms of the will.
- Open a separate fiduciary (estate) bank account at a bank that can provide you with the original canceled checks or statements with images of all canceled checks.

That money was to be dispersed in grants to as many as 33 organizations, including one to Kilpatrick's Vets Recover clinic. Another would go to the Military Officers Association of America, which Kilpatrick represents on the state board. The complaint claims that Kilpatrick recused himself from votes on the "Supporting Alabama's Veterans Grant Program." Kilpatrick, a 38-year military veteran and a colonel in the U.S. Army Reserve, reiterated that to ADN Wednesday.

November 5th is just two months away. Elections reflect the will of the people. But in Alabama, there are generally fewer people than normal making those decisions. Alabama's overall voter turnout consistently trails national averages, and is often near the bottom in the South, which generally has the lowest turnout numbers in the nation. Make this election different...VOTE.

The July 2024 Consumer Price Index for Urban Wage Earners and Clerical Workers, on 14 August was 308.501, 2.4% above the FY 2024 baseline of 301.236. August 2024 figures will be announced Sept. 11. The CPI-W figures from the end of this fiscal year (July, August, and September 2024) will be compared to the FY 2024 COLA baseline to calculate the 2025 COLA.

Guest Speaker: RADM Kent Davis Commissioner, Alabama Department of Veterans Affairs

Rear Admiral W. Kent Davis, USN (Retired) became the seventh Commissioner of the Alabama Department of Veterans Affairs on February 19, 2019, upon selection by the State Board of Veterans Affairs. As Commissioner, he manages the agency's operations, coordinates mission execution, and oversees the work of approximately 1,200 state and contractor employees in 70 facilities throughout Alabama. He also manages an annual agency budget of over \$190 million as well as state benefits and services for approximately 400,000 Alabama Veterans and their families.

The son of a combat-wounded World War II U.S. Army Veteran, Commissioner Davis was born in Montgomery and also grew up in Atlanta and New Orleans. A National Merit Scholar, he attended Louisiana State University on an academic scholarship, receiving a Bachelor of Science degree in Business Administration in 1985. While attending college he joined the Navy.

His assignments included the USS Missouri, USS Abraham Lincoln, law school at Georgia State University, US Army JAG Corp at Fort McPherson, the law firm of King & Spalding in Atlanta, US Central Command, US Joint Forces Command, US Sixth Fleet, the Navy Office of Information and the Department of Homeland Security.

In 2016, Commissioner Davis retired from the military after almost 31 years in uniform and became the Director of Economic Development and then City Manager of Anniston for almost two years. In late 2017, he was hired as the (civilian) Director of Communication and Outreach at Air University at Maxwell Air Force Base and moved back to his hometown of Montgomery.

Commissioner Davis is the recipient of many military and civilian awards, and has published numerous scholarly pieces in legal journals, college textbooks, and defense publications around the nation.

Commissioner Davis has been married to Lieutenant Commander Lisa Davis, USN (Retired) for 32 years. They have a daughter who is a student at the University of Alabama and a son who is a student at Auburn University.

Three Steps to Stay Sane in a Volatile Market

Many investors are facing an internal struggle: We know we need to invest, but a volatile market makes yearn for "safe" places to put our money.

Why? Because we experience losses about twice as severely as equivalent gains -- a phenomenon known as "<u>loss aversion</u>" in the world of behavioral economics.

Loss aversion and other biases can cause us to act irrationally. A significant market dip – and the scary financial news flashes and dire predictions that come with it – might make us want to guard our money instead of risking it in the markets. We might consider moving it all into low-risk investments like bonds or certificates of deposit or high-yield savings accounts.

But for most of us, such a move would be a costly mistake that could set our retirement plans back years.

No matter the short-term fluctuations of the stock market, these tips will help you keep your sanity ... and your solvency:

1. Don't look at your accounts right now. Unless absolutely necessary, resist taking a peek at your investment accounts. This will help prevent your primitive brain, prone to all those behavioral biases, from panicking and doing something rash.

2. Put things in perspective. If you don't need to withdraw from your investments for decades, then a drop in the market can be viewed as something of a fire sale – one that, in the long run, will help you grow your portfolio. This assumes you are continuing to practice <u>dollar cost averaging</u>, an investment strategy where you are making regular investments in the market. It also assumes that you are staying the course, keeping your money in the market for the long haul.

If you're closer to retiring from the workforce, say 15-20 years out, you still have plenty of time to recover from market fluctuations as long as your <u>portfolio is allocated properly</u>. If you don't know how to allocate your portfolio, you could consider investing in a <u>target date fund</u> (like the Thrift Savings Plan's Lifecycle funds).

If you are five or less years away from retirement, hopefully you have already moved some of your portfolio into less-risky investments such as bonds and cash.

Those in retirement and withdrawing from their investments should have a sizeable cash reserve and a portfolio structured to weather a prolonged market downturn.

3. Get help if you need it. If the words "asset allocation" sound intimidating and the idea of a hands-on approach to investing makes you nervous, you might want to call in a professional.

I am a big proponent of getting a periodic reality check from a <u>fee-only financial planner</u>. Yes, this costs a bit, but retirement withdrawal planning is complicated. You don't want to get this wrong.

If you are experiencing financial difficulties and need help with debt management or are going through a life transition and want guidance on creating a spending plan, you can get free financial counseling through the <u>Veterans Benefits Banking Program</u>. Active duty servicemembers and retirees also can access financial counselors at their <u>nearest family readiness center</u>.

Natural Disaster Scams

Overview

When natural disasters hit, fraudsters are usually not far behind. Sadly, victims rebuilding their homes and lives are seen as easy targets by scam artists. To avoid this, keep your personal information secure and be wary of anyone who approaches you offering quick access to relief funds or rebuilding help.

Amidst the chaos of preparing for tornadoes, hurricanes, wildfires, floods, or other kinds of emergencies, there's another threat that often lurks unnoticed: scams targeting vulnerable individuals during times of crisis.

Scammers have been known to take advantage of disaster situations, often preying on those seeking help to rebuild their homes and lives.

After <u>wildfires struck the Hawaiian island of Maui</u> in 2023, real estate scams quickly followed. In the <u>aftermath of Hurricane Ian</u> last year, Florida officials immediately warned residents about contractor fraud, debris removal scams, and other similar threats.

If you live in an area prone to natural disasters like these, stay one step ahead by knowing how con artists strike in times of trouble.

Common disaster scams

The <u>Federal Trade Commission</u> reports that there are four types of scams that are commonly seen after a natural disaster or weather emergency.

- **Imposter scams:** To gain your trust, fraudsters pose as government officials, inspectors, utility workers, or even Federal Emergency Management Agency (FEMA) staff. They'll tell you that they need access to your <u>personal information</u>, like your Social Security or bank account number, so they can begin the required work on your home. Or they even may tell you that you need to pay a fee to file an application with FEMA and obtain relief funds.
- **Construction scams:** Individuals posing as contractors may canvas recovery areas offering quick repairs or debris removal services. They may demand cash up front or try to get you to sign over your insurance check. They may also claim they don't need to be licensed or try to get you to sign a blank contract.
- **Rental listing scams:** Since many people may need temporary housing after a disaster hits, scammers sometimes advertise <u>bogus rentals</u>, requesting security deposits or wire transfers that they then steal.
- **Charity scams:** In the aftermath of a weather emergency or natural disaster, there may be fraudulent charities or individuals pretending to represent legitimate organizations that approach you to solicit donations.

How to avoid disaster scams

The best way to avoid these natural disaster scams is knowing how to recognize them and avoid taking the bait.

• **Don't give out your sensitive personal information.** Never share your sensitive details with a stranger without first requesting their identification and verifying they are legitimate (whether it's a government worker, contractor, broker, management company and/or landlord).

- **Be wary of anyone pressuring you to make decisions quickly** or provide payment upfront, without allowing you to verify their credentials or get further information.
- Avoid paying with cash, wire transfers, cryptocurrency, or gift cards. Payment in these forms is harder to trace, and it will be difficult or impossible to get your money back if you encounter a thief.
- Watch out for people offering to expedite FEMA applications and insurance claims or promising unusually high settlements. Contact <u>FEMA</u> or your insurance company directly to verify any offers or applications.

What to do before a storm hits

There are a few things you can do to stay ahead of the scams that may appear after a major weather event in your area. While it may be challenging to add these measures to your already long list of preparations, it's the best way to protect your identity and financial future.

- **Review your insurance policy.** Check your policy to make sure you're aware of what types of damages are covered and who to contact if you need to file a claim.
- **Research contractors in your area.** You can secure recommendations, read reviews, and review potential contractors' credentials early, then keep a list of people you feel secure using, if needed.
- Store backups of critical information. In addition to having physical copies of your personal information (stored in a secure location like an anchored safe), you may also want to have digital backups, like on an external hard drive or cloud storage like iCloud or Dropbox.
- Stay in the know. Visit <u>FEMA.gov</u> and download the <u>FEMA Mobile App</u> to get up-to-date alerts and relief information before and after disaster hits.

Resources for financial help after a disaster

- **FEMA disaster relief:** FEMA operates a Disaster Housing Program to help people who have been forced out of their homes by disasters. This includes Disaster Home Repair Assistance, which gives grants to people for minor but necessary disaster-related repairs. Call the FEMA Disaster Helpline at 1-800-621-FEMA or visit <u>Disasterassitance.gov</u>.
- **SBA loans**: The <u>U.S. Small Business Administration</u> makes low-interest loans of up to \$200,000 to homeowners to repair or replace their primary residence.
- **HUD disaster recovery:** The U.S. Department of Housing and Urban Development (HUD) provides disaster recovery funds. To apply, <u>contact your state or local community development office</u>.

What to do if you fall victim to a disaster scam

Sometimes even with careful preparation, you may fall victim to fraud. If you think you've been hit by a scam or if you've spotted one in your area, report it to the FTC at <u>ReportFraud.ftc.gov</u>. Your report could help the FTC stop scams and help save others.

Disaster preparedness is not just about physical readiness, but also about protecting yourself from financial and emotional harm. By understanding your risks, securing your assets, and staying vigilant, you can weather the storm with greater resilience.

TRICARE Fraud Alert: TRICARE For Life Phishing Scam

If you've recently gotten a suspicious text message about your TRICARE coverage, don't respond. Instead, report it to TRICARE.

Some beneficiaries have gotten a text message from 888-763-0248. The sender claims to be <u>Wisconsin Physicians Service</u>, the TRICARE For Life contractor. But the text message is really part of a phishing scam targeting <u>TRICARE For Life</u> beneficiaries. The message says the recipient's TRICARE coverage will expire due to nonpayment. It tells the recipient to call a toll-free number.

"The Defense Health Agency has recently learned of this phishing scam," said Anne Breslin, TRICARE For Life program manager at the Defense Health Agency. "While it seems to be aimed at TFL beneficiaries, scammers may try to target anyone who has a TRICARE plan. You should stay aware and report any suspicious messages or calls that say they're from TRICARE."

It's important to know that WPS doesn't collect payments. Also, WPS won't try to contact you via text message.

TRICARE will never text or call you asking for:

- Payment
- Personal identifying information

Keep these tips in mind when it comes to your personal information:

- Never share personal or financial information with someone you don't know.
- Don't open unsolicited, unexpected text messages or emails.
- Don't open links from unknown numbers or emails. Instead, contact your <u>TRICARE</u> <u>contractor</u> using a phone number or website you know is real to verify that they're trying to reach you.

Reporting scams

Have you or someone you know gotten this scam text message? You should report any suspected fraud or abuse related to your TRICARE benefits.

There are two ways to <u>make a report</u>:

- **Option 1:** Contact your TRICARE contractor.
 - **TFL beneficiaries:** Contact <u>WPS</u>.
 - **Others:** Contact the appropriate <u>TRICARE contractor</u>. This may be your regional contractor, the pharmacy contractor, or the Dental Program contractor.

• **Option 2:** Contact the <u>DHA Office of the Inspector General</u>.

Give as much information as possible when you make your report. This may include names, dates, and details. Investigations are confidential. You can choose to remain anonymous.

Protect your personal information. Treat it like a credit card. If someone contacts you by phone, email, or text message asking for this information, don't provide it. Instead, report it to your TRICARE contractor right away.

There are many types of phishing scams targeted toward the military community. For more information, check out <u>Military OneSource</u>.

- Take possession of the assets of the deceased and inquire about safe deposit boxes and accounts they may have maintained.
- Make an online search for any unclaimed property in the name of the deceased.
- Close bank accounts and transfer funds in a separate account (create an estate account with a separate tax identification number).
- Follow the disbursements to heirs as instructed in the will.
- Document all transactions and prepare to file income tax.
