#### Other Items of Interest:

#### - VFW Helps VA Battle Backlog

The VA recently began pushing "Fully Developed Claims" to help break a 1.9 million-claim backlog by the year 2015. VFW National Commander Bill Thien said his nationwide cadre of 1,200 VA-accredited service officers has always strived to submit fully developed claims, and that this was reemphasized in service officer training a year ago. The VA considers claims to be "fully developed" when all available supporting documentation or evidence within the control of the veteran is submitted with the application. Thien said it is important that every claim be as fully developed as possible because it normally takes well over six months for a new claim to get adjudicated, and if denied for insufficient



# Fox Army Health Center Department of Pathology Receives Accreditation from College of American Pathologists (CAP)

#### Fox Army Health Center Ends Furlough

We kindly thank your patience and indulgence during the mandatory furloughs. Our last day of furlough was Friday, 16 August 2013, and we will resume normal operating hours the week of 19-August 2013.

Fox Army Health Center's normal operating hours are Monday-Friday from 7am-4:30pm. As a Reminder, the Health Center will close at 2pm on the first Thursday of each month, and closed the entire day on Saturday, Sunday, and all federal holidays. Advice Nurses are available during non-duty hours at (256) 955-8888 or 1-800-223-9531 to provide care advice. Fox is an ambulatory care clinic and does not have an emergency room. In an emergency, dial 911.

#### **TRICARE Expands Special Needs Care for Retirees**

The Department of Defense is not making changes for active duty family members seeking autism services. However, an expansion of services through the Applied Behavior Analysis Pilot Program will allow retirees and their families to receive Autism Service Demonstration benefits.

Tricare has long covered ABA for active duty family members as a benefit of the Extended Care Health Option. To increase access to ABA services, in March 2008 the DoD implemented the ECHO Autism Demonstration for active duty family members. The demonstration expanded the opportunity for access to ABA services through a variety of provider types, to include ABA "reinforcement" by tutors. ABA reinforcement by tutors has not been available for non-active duty family members.

Beginning July 25, autism services available to non-active duty family members are greatly expanded with the introduction of the ABA Pilot Program. The pilot program provides retirees and their families with access to additional areas of ABA reinforcement. Autism care and treatment is evolving, and the pilot program is expected to provide insight into evaluation protocols. It was developed by crafting requirements through consultation with experts in the field and with advocacy groups in an attempt to discover validated tests, and the best approach for focusing on what would be the most appropriate care in order to provide the best possible outcomes for children with autism.

Dr. Jonathan Woodson, assistant secretary of defense for health affairs and director of the TRICARE Management Activity, said it is "paramount" for children with autism to obtain professional reassessments to ensure they get the right care, at the right time, with updated care plans.

Autism care benefits for qualifying children of active-duty service members enrolled in Tricare will not change. There is also no change in benefits for anyone enrolled in the basic medical program that began July 2012, according to officials at the Southern Regional Medical Command.

#### **Fox Army Health Center Welcome New Providers**

They come from two distinctly different paths – one who vowed she would never be a nurse, another who always knew he wanted to be a doctor – but together, they are working to help Fox Army Health Center's beneficiaries live a lifetime of wellness.

Fox Army Health Center recently welcomed nurse practitioner LTC Carla Crouch and physician MAJ Francisco Rubio to its patient centered medical home.

"These outstanding professionals are a great addition to the Fox Team", said COL William Darby, Fox Army Health Center Commander. "Their experience and competence will enable Fox to improve on the great quality care that we already provide to our beneficiaries."

Born and raised in Indiana, Crouch never intended to be a nurse. Taking one look at her two sisters' careers in nursing, Crouch instead pursued a career in the lab. But after a few microbiology courses waiting for things to grow in Petri dishes, Crouch realized that her sisters were on to something.

"I figured out myself that I'm a people person," said Crouch, who longed for more interaction. "That was just the natural path for me."

Joining the Army National Guard to fund her education, Crouch spent the first nine years of her career in the Indiana National Guard working on her bachelor's degree in nursing, while also serving as a medic. Upon receiving her degree she took a direct commission on active duty and has since served in Korea, where she was assigned to the 43rd MASH before it was deactivated. LTC Crouch also served in Germany and Kosovo as well as, serving stateside at Brooke Army Medical Center, Ft. Irwin, CA, and Ft. Riley, KS, where she completed her masters to become a nurse practitioner at the Uniformed Services University of the Health Sciences.

Coming to Fox Army Health Center, Crouch has a hands-on role as chief of the facility's patient centered medical home, a team focused approach that puts the patient's needs and wellness at the center of their medical care. Beneficiaries are assigned to a specific team – red, white or blue – which consists of a primary care provider, two licensed practical nurses and a registered nurse.

"Patient centered medical home benefits the patient because they can have some expectations from their team," Crouch said. "Knowing where to go to get answers is key to moving along in a care plan for someone." One of the primary goals of patient care is helping beneficiaries live a lifetime of wellness, not just coming in to Fox when something is wrong with their health.

"We do a lot of wellness reiteration," Crouch said. "That's the biggest change about health care with patient centered medical home is that we're looking forward to their health, not just what's happening right here today. As people get older, certain screenings needs to happen, and that's at the forefront of the team's mind. Have they had a colonoscopy? Have they had a mammogram? Those kind of preventive measures are being looked at by the entire team, and that helps tremendously."

Efforts are currently under way to fill Fox's vacant family practice positions within the three teams, allowing beneficiaries better access to appointments and improved patient care.

"The big message for patients is to understand when they call for an appointment, we are going to make every effort to ensure they have their appointment with their assigned provider," Crouch said. "Now that we've got more

more providers, we're going to be able to maintain that standard of having the right patient with the right provider at the right time."

MAJ Rubio is one of those new family care physicians at Fox and is responsible for the blue team. For as long as the Miami native can remember, he has wanted to be a doctor. Over the course of his 15 years in service to his country, he has served at places such as Ft. Rucker, Ft. Bragg, Ft. Stewart, Bosnia, Afghanistan, Iraq, and now Redstone Arsenal, where he is happy to exercise his helpful nature.

"I love just being able to help people, to help them feel better and stay healthy," Rubio said. "It's just gratifying."

One of his favorite parts of his career is evident in the Christmas cards he receives every year, from the smiling families whose lives he has touched as a family medicine doctor.

"Delivering babies at my previous assignment – that's my favorite part," Rubio said. "Being able to take care of the moms throughout their pregnancy, deliver the babies, and then take care of them until I leave. You kind of become part of their family. It's a nice thing."

As the primary care provider for the blue team at Fox, Rubio is granted the opportunity day in and day out to help his fellow Soldiers strive for a lifetime of wellness, and encourages all his beneficiaries to make healthy choices, such as exercising and eating right.

"If you just do the basic stuff, then it's really pretty easy to stay healthy, but unfortunately it's easier said than done," Rubio said. "It's following all the simple stuff that grandma said."

documentation, two years or more just for the appeal. The VFW supports this initiative because a fully developed claim can cut the initial time in half, which helps speed the delivery of VA programs and services to deserving veterans, and helps to reduce the VA's overall claims workload.

# - TRICARE Retiree Dental Program Changes (Rick West and John Inman should be proud-this one came from the Fleet Reserve Association)

Effective October 1, 2013, all TRICARE Retiree Dental Program (TRDP) beneficiaries will be required to pay their monthly premiums by an Electronic Funds Transfer (EFT) or through military retired pay allotment. The ability to pay premiums by check or through an online bill pay system will end in September.

Most TRDP enrollees will need to take no action; however, Delta Dental sent letters to all TRDP participants on July 19 with information on where to submit EFT authorization forms and how to submit an EFT authorization online at <a href="https://www.trdp.org">www.trdp.org</a>.

Delta Dental of California will continue managing the TRICARE Retiree Dental Program through 2018. As a result of this continued relationship, TRDP enhanced the program and overseas participants can look forward to several changes effective January 1, 2014.

### 2013 ALUMNI AWARDS

The University of Kentucky Law Alumni Association and Board of Directors established five awards to honor graduates who have distinguished themselves by contributions to the practice of law and service to communities.

#### Class of 1955 - GEORGE D. SCHRADER

George D. Schrader served 22 years in the US Air Force and 5 years as Staff Judge Advocate, Alabama State Defense Force. Colonel Schrader initiated a program with the lawyer referral service providing a 25% discount for legal services provided to active, reserve, National Guard and retired members of the armed forces. He holds six degrees from five universities, has authored over 50 articles on law and management and authored or co-authored six books.

He served on the faculty of Auburn University at Montgomery, retiring as Professor Emeritus. He served on the board of directors of the Montgomery Area Council on Aging, was treasurer of the Montgomery Chapter of the Military Officers Association Scholarship Foundation and Historian for that Chapter. He served as Program Chairman of the Baptist Hospital Senior Advantage Organization, fundraiser for the Boy Scouts and Project Officer for the dedication of a highway bridge in honor of a Medal of Honor recipient.

Schrader served as Chairman of his neighborhood community council, head usher at his church and on the church supervisory committee. He helped establish the legal assistance section of the Montgomery County Bar Association, served on the editorial board of Alabama Lawyer and on several Alabama State Bar committees.



- An increase in the annual maximum amount for each person enrolled, to \$1,300
- Coverage year will run from January 1 through December 31
- Maximums and deductibles will restart every January 1An increase in the annual maximum amount for dental accident coverage for each person enrolled, to \$1,200
- An increase in the lifetime orthodontic maximum amount for each person enrolled, to \$1,750
- A third cleaning allowed for children and adults with documented Type 1 or Type 2 diabetes
- A decrease in monthly premiums

TDRP basic participants can also look forward to a lower premium. Current dental enrollment cards will remain valid under the new contract; however, verification of TRDP eligibility and enrollment will be managed by Defense Eligibility Enrollment System (DEERS).

#### **Agent Orange Update (as reported in The Washington Post)**

On Tuesday, August 6, The Vietnam Veterans of America North Dakota State Council launched a statewide Agent Orange Education Campaign with the unveiling the first of a series of billboards. Their goal is to reach fellow veterans and their dependents exposed to and suffering from the effects of Agent Orange/dioxin.

"Through advertisements such as our billboards and by convening town hall meetings, stand downs, and other outreach events throughout North Dakota, we hope to reach those suffering from the effects of Agent Orange to provide them with information and resources they need," said *Dan Stenvold*, President of the VVA North Dakota State Council.

"Along with the North Dakota Department of Veterans of Affairs, we will be working with many organizations to contact those who may have been exposed and their families. We are grateful to the North Dakota 63rd legislative assembly, which appropriated a \$50,000 grant for 2013-2015, in support of our outreach efforts," said *Stenvold*.

VVA is committed to ensuring that all veterans exposed during their service receive the care and compensation they have earned by their service to our nation. This includes those who served in Vietnam, Thailand, Cambodia, Korea, and Laos, as well as those who flew on C-123s, aboard Navy vessels, and on certain military installations and other facilities on and outside the continental U.S., including Guam, Puerto Rico, Hawaii, Johnson Island, Ft. Detrick, and elsewhere.
