# Legislative Corner Lt Col Charles Clements, USAF-Ret





"All politics is local."

Voter turnout for the Alabama Primary election was 21.05% on 7 March, according to the Secretary of State. Former Department of Justice official Shomari Figures and Alabama House Minority Leader Anthony Daniels are headed to a runoff for the Democratic nomination in the newly-drawn 2nd Congressional District. Former Sen. Dick Brewbaker of Pike Road and attorney Caroleene Dobson are headed to a runoff for the Republican nomination for the 2nd Congressional District.

U.S. Rep. Barry Moore, R-Enterprise, won the Republican nomination Tuesday for the Alabama 1st Congressional District, which stretches from Mobile through the Wiregrass. Moore, who currently represents the 2nd Congressional District, will face presumptive Democratic nominee Tom Holmes in the November general election.

Sarah Stewart, an associate justice on the Alabama Supreme Court, won the Republican nomination for Alabama Chief Justice.

The Alabama Legislature will have to keep a procedural vote before considering local bills after voters rejected a proposed constitutional amendment.

The runoff for the contested nominations is on 16 April.

A special general election for House District 10 is set for 26 March. This is to replace former Rep. David Cole, R-Madison, had to resign the seat last fall after entering a plea deal on a felony voter fraud charge. The Democrat nominee is Marilyn Lands, and the Republican nominee is Teddy Powell.

Governor Ivey signed a bill on 7 March approving the education savings account. The legislation provides up to \$7,000 in tax credits for families to use on private school education or other education options. Home school families can receive up to \$2,000 in credits per child, capped at \$4,000 per family. The Creating Hope and Opportunity for Our Students' Education or CHOOSE Act has been a GOP priority and promise to school choice advocates.

The Alabama Veterans Affairs (ADVA) was 'blindsided' by a new veterans' health care system proposal in early March. HB 197 and SB 135, originally read into the record on 24 February, would direct the ADVA to establish and operate a statewide health care system for Alabama veterans and their families. The Alabama Department of Veterans Affairs held two special-called board meetings on 5 March after the filing of two bills that members said came as a surprise to



## **New Feature of MHS GENESIS Patient Portal Allows Prescription Refills**

The Defense Health Agency has launched a new feature that lets you request prescription refills through MHS GENESIS. MHS GENESIS is the Department of Defense's new electronic health record. It's now in use at every military hospital and clinic worldwide.

Prescription refills through the MHS GENESIS Patient Portal became available on Feb. 29. In the first week, the Military Health System processed nearly 30,000 refills using the portal request.

This new capacity within MHS GENESIS is something that was desired by beneficiaries," said U.S. Public Health Service Lt. Cmdr. Minh Doan, patient portal solution owner for the DHA. "It is another tool for beneficiaries to manage their own health care."

You can now easily refill your prescriptions by selecting the "Rx Refills" tab in the upper right panel on the portal's homepage.

Through your MHS GENESIS Patient Portal, you'll be able to:

- See all your prescriptions that are available to be refilled.
- Choose which ones you want refilled.
- Choose where you want to pick up the refill.
- See when your prescriptions are ready to be picked up.

This is an example of how the DHA is working to meet the patient where they are to make health care access more convenient." Doan added.

This new feature applies to existing prescriptions that have remaining refills, said U.S. Navy Capt. Angie Klinski, deputy chief, MHS GENESIS pharmacy solution owner.

According to Klinski, the system determines a prescription is ready to be refilled when you've completed 75% of the previous fill. Your prescriptions won't be eligible for refill before that time.

You need a renewal when your prescription has no refills left, or has expired, and you still need the medication. You can use the MHS GENESIS secure messaging feature to request a renewal. You may also need to talk to your provider first before you can renew your prescription.

## <u>Surviving Spouse Corner: Are Your Personal Documents Ready</u> for an Emergency?

them. Member by member, the 17-person ADVA Legislative Committee all shared similar sentiments on the bills: That while health care for veterans did need to be improved in the state, the scope of the proposal could exceed the manpower or funding resources of the department.

The Alabama Senate on 7 March approved gambling legislation from the House of Representatives, but only after making substantial changes. The House originally created a lottery and a state gambling commission and allowed casino gaming and sports wagering at seven different locations in the state. It also directed Governor Ivey to negotiate a compact with the Poarch Band of Creek Indians, who operate casinos in Atmore, Montgomery, and Wetumpka. The Senate version keeps the lottery and compact language but dropped sports wagering and casino gaming. The bill would only allow pari-mutuel betting and historic horse racing machines at the seven locations. More to come.

On 13 March Governor Ivey signed a bill aimed at restarting in vitro fertilization (IVF) services in the state, minutes after the Alabama Legislature gave final approval to the legislation.

The Alabama Senate sent two controversial bills to Governor Ivey's desk on 19 March. The legislature sent SB 1 that would prohibit any payment for assistance in absentee ballot applications or to "knowingly" provide an absentee ballot with pre-filled information. Gudger said the purpose of the bill was for election integrity. The other is SB 129 that limits the use of public funds for DEI (Diversity, Equality and Inclusion) efforts and outlines a number of "divisive concepts" that teachers or other public employees cannot compel others to accept or conform. Divisive concepts include "the moral character of an individual is determined by his or her race, color, religion, sex, ethnicity, or national origin" and "meritocracy or traits such as a hard work ethic are racist or sexist."

February's 2024 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W), released March 12, was 304.284, 1.0% above the FY 2024 baseline of 301.236. March 2024 figures will be announced April 10.

## Tax Day - Monday, Apr 15, 2024

The IRS reminds taxpayers the deadline to file a 2023 tax return and pay any tax owed is Monday, April 15, 2024. Taxpayers living in Maine or Massachusetts have until April 17, 2024, due to the Patriot's Day and Emancipation Day holidays.

Since 1955, Tax Day has typically fallen on or just after April 15. Tax Day was first introduced in 1913, when the Sixteenth Amendment was ratified.

Furthermore, having your important documents organized facilitates seamless communication and coordination with emergency responders and relief agencies. ## **Governing Board Vacancies**


The Chapter has several vacancies on the Governing Board that we are looking to fill with volunteers from the membership. They include:

He graduated with a Bachelor of Science degree from Purdue University in 1961 and was designated a Distinguished Military Graduate of the ROTC program and was commissioned in Army Ordnance Corps. He later received master's degrees in business administration from Indiana University and in systems management from the University of Southern California.

During his Army career he served in Vietnam, Germany, and Korea, as well as in numerous locations in the United States. His final assignment was with the Ordnance Center and School at Redstone Arsenal. After retirement from the Army in 1987, Mr. Pray worked for CAS, Inc. in Huntsville as a program analyst and manager. 
## **Total Solar Eclipse**

The Monday, April 8, 2024, total solar eclipse will cross North America, passing over Mexico, the United States, and Canada. The total solar eclipse will begin over the South Pacific Ocean. Weather permitting, the first location in continental North America that will experience totality is Mexico's Pacific coast at around 11:07 a.m. PDT.

The path of the eclipse continues from Mexico, entering the United States in Texas, and traveling through Oklahoma, Arkansas, Missouri, Illinois, Kentucky, Indiana, Ohio, Pennsylvania, New York, Vermont, New Hampshire, and Maine. Small parts of Tennessee and Michigan will also experience the total solar eclipse. The eclipse will enter Canada in Southern Ontario, and continue through Quebec, New Brunswick, Prince Edward Island, and Cape Breton. The eclipse will exit continental North America on the Atlantic coast of Newfoundland, Canada, at 5:16 p.m. NDT.

## **Top 3 Identity Crimes**

#### Overview

In 2023, victims were most affected by false applications, new account fraud, and tax fraud. Learn how these schemes work, whether they still pose a threat, and how you can stay protected in 2024 and beyond.

Through it all, reports of fraudulent applications, new account fraud, and tax fraud continued to come in, revealing a pattern similar to previous years.

Identity thieves are known to switch up their tactics but it's clear that these identity crimes will remain a threat in the coming year. Stay one step ahead in 2024 — and beyond.

#### **Fraudulent applications** were the most common crime.

In this scheme, fraudsters steal and use your personal information to apply for a line of credit in your name like a loan, mortgage, credit card, or auto lease. A lender must then review this credit application, which can trigger a "new inquiry" on your credit report.

If the fraudster successfully opens this new account or line of credit in your name, that's considered new account fraud, the second most common fraud type.

Criminals also frequently apply for checking and savings accounts using stolen personal information. It's become easier for fraudsters to apply for fraudulent bank accounts partly due to the increased access and popularity of online banking. Sometimes, it only takes a few pieces of information to create an online profile.

While these digital applications are convenient, they can present challenges to both financial entities and consumers.

#### Identifying a fraudulent inquiry on your credit report

A new inquiry on your credit report may be fraudulent if you know you haven't...

- Recently applied for a line of credit like a new credit card or auto loan.
- Been added as an authorized user to a line of credit.
- Cosigned a line of credit for someone else.

#### **New account fraud** had the greatest financial impact.

When you're approved for a new credit line or listed as an authorized user on an account, your credit report may show a "new account."

Opening a new credit account typically requires your detailed personal information like Social Security number or driver's license. Some accounts even require proof of income or address.

When a criminal gets access to this kind of personal information, they could open a new account on your behalf, resulting in new account fraud or "account opening fraud."

For new checking or savings accounts, it may be as simple as providing a photo ID.

While the number of new account-related crimes decreased by 18 percent from 2022 to 2023, it remained the second most frequently reported last year.

How do criminals steal the information they need to commit these crimes? Their methods of attack range from phishing to data breaches to malware.

Phishing attacks are growing in both frequency and sophistication. When in doubt, do not disclose any personal information until you are certain that the communication is from a trusted source.

#### Identifying new account fraud

You can tell if someone has opened an account in your name if you...

- receive snail mail or email with information about an account you don't recognize.
- get a message from your bank that says someone has changed your account information like your phone number or email address.
- see information about a new account you didn't open when you review your bank statement or when you log in to your online bank.

#### Government and tax fraud peaked in the first half of the year

Another troubling pattern? Tax fraud spiked in the first two quarters of 2023 and was the third most reported crime for the year.

The weeks leading up to the tax filing deadline (typically mid-April for most Americans) are prime time for scammers to pose as IRS employees, attempting to get your information to file your taxes under your name.

Although we saw a decrease in this case type in the second half of the year, our identity specialists recommend staying vigilant for calls and texts from people claiming to be from the IRS all year long. File your taxes as soon as you receive your W2 or other relevant tax documents to prevent a criminal from filing on your behalf.

Since the IRS only accepts one submission per taxpayer, anyone attempting to file a tax return after you have already filed electronically or by mail will be rejected.

#### **Identifying tax fraud**

You can tell if someone has filed a tax return in your name if...

- The IRS shows that you have filed more than one tax return.
- You have a balance due or have had collection actions taken against you for a year you didn't file taxes.
- It's reported that you received wages from an unknown employer.

#### Looking ahead to identity theft in 2024

Fraudulent applications, new account fraud, and tax fraud have been common crimes in the past few years and that trend is likely to continue.

One thing's clear: Fraudsters are eager to take advantage of your personal information through any means necessary.

## See What's in Store for the TRICARE Pharmacy Program in 2024

The most recent TRICARE pharmacy contract, known as TRICARE Pharmacy 5th Generation (TPharm5), started on Jan. 1, 2023. Since then, you may have experienced some enhancements to how you get your prescription drugs. In 2024, you can continue to expect improved access to pharmacy benefit services through the TRICARE Pharmacy Program.

"The Defense Health Agency listened to our beneficiaries' concerns and needs. We responded with several enhancements to the pharmacy contract that went into effect last year," said U.S. Public Health Service Cmdr. Teisha A. Robertson, Deputy Chief of the Purchased Care Branch at the Defense Health Agency. "This year, we'll continue to roll out improvements. These improvements include new specialty pharmacy services, cost control measures, and a more efficient home delivery process."

Here are some TRICARE Pharmacy Program updates to note.

#### 2024 cost updates

Your options for filling your prescriptions are <u>military pharmacies</u>, <u>TRICARE Home Delivery</u>, <u>retail network pharmacies</u>, and <u>non-network pharmacies</u>. Prescription copayments for most beneficiaries changed on Jan. 1. To see your costs, check out the <u>TRICARE Costs and Fees Fact Sheet</u>. As noted in this fact sheet, active-duty service members (ADSMs) pay nothing for covered drugs from military pharmacies, home delivery, and retail network pharmacies.

Want to know the copayment for your prescription? Check the <u>TRICARE Formulary Search Tool</u>. You can search for your drug to see if it's covered, how much it will cost, and where you can get it.

## Military pharmacy tools

If you get prescriptions at a military pharmacy, you may be able to use certain tools to avoid long pick-up lines. Check with your military pharmacy to see if it offers these tools:

- Q-Anywhere lets you quickly activate a new prescription by texting your military pharmacy or scanning your pharmacy's unique QR code. You'll get a text when your prescription is ready for pick-up.
- <u>ScriptCenters</u> are automated kiosks and locker systems that give you a safe, secure way to pick up prescriptions. You can use them to pick up prescriptions after hours or avoid crowds at the pharmacy. Each location sets its own hours, but some are open 24/7.

#### **TRICARE Home Delivery**

TRICARE Home Delivery is a convenient way to have up to a 90-day supply of medication shipped right to you.

With home delivery, you can manage your prescriptions from the Express Scripts Pharmacy Mobile App. You'll also have 24/7 access to pharmacists who can answer questions about your prescription.

The TRICARE Pharmacy Program is also making sure that you only receive your medications when you need them. Express Scripts requires you to give consent on every refill in the <u>Automatic Refill Program</u>. You'll need to consent via email, text message, or phone call before Express Scripts will fill your prescription.

## **Specialty drugs changes**

Effective March 1, <u>Accredo provides specialty drugs</u> and enhanced clinical services if you fill <u>TRICARE-defined specialty prescriptions</u> with TRICARE Home Delivery. Accredo is in the TRICARE network as a retail pharmacy.

With Accredo, you have 24/7 access to a clinical care team who can help you manage your treatment with specialty drugs. These expanded services are provided at no extra cost beyond your TRICARE cost-share.

This change improves cost efficiency in the Military Health System (MHS). Increasing the use of home delivery helps the MHS keep your prescription costs lower.

If you already get your specialty drug through home delivery, your prescription has been transferred to Accredo. If you were getting your prescription at a network pharmacy, Express Scripts contacted you. To contact Accredo, call 1-877-882-3324. An Accredo patient care advocate will work with you and your military or civilian prescriber as needed. To learn more, go to Accredo.

## TRICARE retail network pharmacies

Looking for a retail network pharmacy in your area? You may find that there's a network pharmacy closer than you thought. TPharm5 network <u>access standards</u> state there must be at least one pharmacy within 15 minutes driving time of 90% of TRICARE beneficiaries. It's easy to find a retail network pharmacy near you with the Express Scripts <u>Find a Pharmacy</u> tool. Enter your ZIP code to see a map of network pharmacies nearby. Stay updated on your pharmacy benefit throughout 2024. Read more about the <u>TRICARE Pharmacy Program</u>.
