"All politics is local."

President Donald Trump and Congress are on the verge of passing actual bipartisan legislation that would ever so slightly ease mass incarceration. The bill, known as the First Step Act, would take modest steps to reform the federal criminal justice system and ease some punitive prison sentences. It would affect only the federal system — which, with about 181,000 imprisoned people, holds a small but significant fraction of the US jail and prison population of 2.1 million.

Here are the major provisions of the First Step Act:

- The bill would make retroactive the reforms enacted by the Fair Sentencing Act of 2010, which reduced the disparity between crack and powder cocaine sentences at the federal level.
- The bill would take several steps to ease mandatory minimum sentences under federal law. It would expand the "safety valve" that judges can use to avoid handing down mandatory minimum sentences. It would ease a "three strikes" rule so people with three or more convictions, automatically get 25 years instead of life. It would restrict the current practice of stacking gun charges against drug offenders to add possibly decades to prison sentences. All of these changes would lead to shorter prison sentences in the future.
- The bill would increase "good time credits" that inmates can earn. Inmates who avoid a disciplinary record can currently get credits of up to 47 days per year incarcerated. The bill increases the cap to 54, allowing well-behaved inmates to cut their prison sentence by an additional week for each year they're incarcerated.
- The bill would allow inmates to get "earned time credits" by participating in more vocational and rehabilitative programs. Those credits would allow them to be released early to halfway houses or home confinement. Not only could this mitigate prison overcrowding, but the hope is that the education programs will reduce the likelihood that an inmate will commit another crime once released and, as a result, reduce both crime and incarceration in the long term.
- The bill would also exclude certain inmates from earning credits, such as undocumented immigrants and people who are convicted of high-level offenses.
- And it would make other changes aimed at improving conditions in

Update DEERS for the New Year

Is your information current in the Defense Enrollment Eligibility Reporting System (DEERS)? Before the year ends, be sure you and your family's information is up to date and correct. Incorrect information in DEERS can cause problems with TRICARE claims and other health care benefits. To remain eligible for TRICARE coverage, you must keep your information up to date in DEERS.

What is DEERS?

DEERS is a database of active duty and retired service members, their family members, and others who are eligible for TRICARE. Maintaining your DEERS record is key to getting your TRICARE benefits.

Qualifying Life Events and DEERS

If you experience a Qualifying Life Event (QLE), update DEERS. A QLE is a certain change in your life, such as marriage, the birth of a child, or a child going away to college, which may mean different TRICARE options are available to you. Therefore, it's essential to update and verify your information in DEERS anytime you experience a QLE. Remember, your Social Security number (SSN) and the SSNs of all of your covered family members must be in DEERS for your TRICARE coverage to be accurate.

How to Make Updates

You have several options for updating and verifying DEERS information. You can make changes in person, by phone, online, or by mail. To add or remove family members, visit a local ID card office. Only sponsors can add a family member in DEERS. Family members age 18 and older may update their own contact information. To update your information, choose one of these options:

prisons, including banning the shackling of women during childbirth and requiring that inmates are placed closer to their families.

What will be of interest is how the State of Alabama reacts to this Act. By and large, it seems local municipalities and states will only embrace federal incentives on criminal justice issues if they actually want to adopt the policies being encouraged.

Please read the recent postings to the Legislative portion of our webpage. The posting deals with the income tax provisions, outlawing the time honored "Bread and Water" punishment, and the "\$2.7 trillion enterprise audit that DoD failed.

The National Headhunters of MOAA has outlined action items they think are important to active duty force as well as those who have served, including you. On the MOAA webpage each action item is presented in the following format: Who is Affected; The Issue; and The Remedy.

Did you Know?

Directly and indirectly, approximately 104,000 people work in support of Redstone Arsenal in the Huntsville area, with about \$18 billion of federal funds going into the local economy. The installation accounts for 9.8 percent of Alabama's gross domestic product. The Arsenal is truly a federal platform (Team Redstone) which includes the following organizations: Army Materiel Command, Army Contracting Command, Aviation and Missile Command, Security Assistance Command, Marshall Space Flight Center (NASA), Program Executive Office for Missiles and Space, Missile Defense Agency (OSD), Space and Missile Defense Command/Army Forces Strategic Command, the Aviation and Missile Research Development and Engineering Center, Redstone Test Center, Program Executive Office for Aviation, FBI, Missile and Space Intelligence Center (DIA), and Bureau of Alcohol, Tobacco, Firearms and Explosives. Altogether, some 40,000 people work on Redstone daily and this is expected to increase to about 50,000 by the early 2020s. Interestingly, there are only about 900 military personnel stationed on Redstone Arsenal.

Surviving Spouse Corner: SBP / DIC Offset

SBP allows uniformed services retirees to elect to provide continuing financial support for an eligible survivor. SBP provides the survivor 55% of the servicemember's selected military retired pay. Enrollment is elected at the time of retirement, and the retired member pays 6.5% of retired pay as a premium. Automatic coverage is extended to survivors of servicemembers who die on duty Post-9/11.

Dependency and Indemnity Compensation is a VA program providing a modest annuity of \$1,258 per month (\$15,095 per year) for survivors of veterans whose death is determined to have been caused by military service. Under current law, survivors who are eligible for both SBP and DIC must forfeit a dollar of their SBP annuity for every dollar of DIC received from the VA. Often, the offset wipes out the SBP annuity the military retiree paid for. In such cases, the survivor receives a proportional refund of SBP premiums – with no interest on what often has been many years of premium payments.

In multiple Congresses, a majority of House and Senate members acknowledged the inequity and cosponsored corrective legislation to recognize SBP and DIC are paid for different reasons. SBP is a servicemember-purchased annuity, whereas DIC is an indemnity payment when military service caused the member's death. Further, service-disabled retirees have limited opportunities to purchase additional life insurance, and policies that are available impose exorbitant premiums.

In 2008, Congress acknowledged the inequity in law, authorizing a modest Special Survivor Indemnity Allowance (SSIA) for SBP-DIC widows to begin phasing out the offset. In June 2009, Congress took the next step, increasing SSIA monthly payments to \$200 beginning in FY 2015 and rising to \$310 in FY 2017. Barring an additional law change, SSIA authority will expire May 1, 2018. The accompanying House Armed Services Committee press release stated, "This legislation (SSIA) is latest step in our continuing effort to eliminate the so-called 'widow's tax', which has long denied surviving family members the full payment of their Survivor Benefit Plan benefits... this bill does not completely end the offset ... the House Committee ... will continue to explore every opportunity to pursue legislation that brings us closer to eliminating the 'widow's tax'.

In the ultimate irony, a separate law, validated by the courts, terminates the SBP-DIC offset who remarry at age 57 or later. So current law *punishes* survivors who remarry before age 55 by ending their SBP and DIC eligibility – and punishes survivors age 57 or older who *don't* remarry by imposing the SBP-DIC offset.

No other federal surviving spouse is required to forfeit his or her federal annuity because military service caused their sponsor's death. Further, the offset does not apply to surviving military children – only to the spouse. And no other federal survivor is required to remarry to avoid a reduction in his or her survivor annuity eligibility.

Whether you're worried about your sick child, or need health care advice while traveling, the MHS Nurse Advice Line is only a call or click away.

The registered nurse can:

- Answer your urgent care questions
- Help you understand your symptoms and decide when to visit a provider
- Find an urgent care or emergency care facility
- Schedule an appointment within 24 hours at a military hospital or clinic, if available

You can reach a nurse online 24/7 using secure web chat and video chat. Connect at the MHS Nurse Advice Line website, or find all country-specific numbers listed there for a phone call. If you're in the U.S., Guam, or Puerto Rico, you can call 1-800-TRICARE (1-800-874-2273) and choose option 1. The MHS Nurse Advice Line is only available to beneficiaries living or traveling in the U.S. or a country with an established military hospital or clinic.

The MHS Nurse Advice Line isn't for emergencies. If you have an emergency, call 911 or your local emergency service center, or go to the closest emergency room or facility.

Expanded TRICARE Coverage for Ambulance Services

TRICARE expanded ambulance services to cover both treat-and-release and joint response services this year.

TRICARE now covers:

- Treat-and-release: This is when an ambulance treats you but doesn't take you to the hospital.
- **Joint response**: This is when an ambulance crew needs the help of a paramedic or intermediate EMT to give you advanced life support services.

Ambulances can be network or non-network providers. In an emergency, sometimes a non-network ambulance may treat or transport you. If a non-network provider bills you for treat-and-release or joint response, they can charge up to 115 percent of the TRICARE-allowable charge.

Active duty service members aren't liable for payment for treat-and-release or joint response services.
