"All politics is local."

The presidential election, U.S. Senate contest and seven US House of Representatives races might be the big draws for voters, but there are also six statewide constitutional amendments on the ballot on November 3rd. Several of the proposed changes to the state constitution were approved by lawmakers in the 2019 legislative session. Here's a recap of each.

Amendment 1

If approved by voters, Amendment I would "provide that only a citizen of the United States has the right to vote."

According to the **Fair Ballot Commission**, the state constitution grants the right to vote to U.S. citizens who meet certain requirements. The amendment does not change those requirements. Citizenship is a federal requirement to vote

If a majority of voters vote "yes" for Amendment 1, the state constitution will grant the right to vote to "only" those U.S. citizens who meet the requirements. If a majority of voters vote "no," the state constitution will continue to grant the right to vote to "every" U.S. citizen who meets the requirements, according to the commission.

Legislation for the proposed amendment was sponsored by Sen. Del Marsh, R-Anniston, in 2019. Marsh said he doesn't think non-citizens voting is a big problem in Alabama. But the amendment "sends a message to Washington." "And I think you have a lot of states that do not police this," Marsh said this week.

Marsh's legislation cleared the Senate and House last year without any no votes.

Amendment 2

Amendment 2 proposes to make several changes to the administration and oversight of the state's court system and judges.

Currently, the Alabama chief justice appoints the administrator of courts (AOC), the executive who oversees court operations. If approved, Amendment 2 would allow the full Supreme Court to make the appointment.

Legislation for the proposed amendment was sponsored by Sen. Arthur Orr, R-Decatur. He said the proposal allows for a renewable contract for the administrator and the position would no longer be at the whim of the chief justice. Because the administrator oversees the entire state court system, there





Anger

What does it take to turn a person into a Judas? What motivates someone to betray deep-seated loyalties?

Unresolved anger and resentment for one thing. Consider the story of Earl Pits, FBI agent turned Soviet spy.

According to Evan Thomas in NEWSWEEK, Pitts was raised on a farm in Missouri and was recognized as a Future Farmer of America. His parents said they disciplined him firmly but fairly. He was a captain in the army who regarded himself as a patriot. Even today he is described by his wife as a "good man." So, what happened?

After getting his law degree and serving as a military policeman for six years, in 1983 Pitts realized a lifelong ambition by going to work for the FBI. In 1987 he was assigned to the New York office, and there his troubles began. He did not see how he could afford to live in the Big Apple on his \$25,000 salary.

Thomas writes, "Morale in the office was poor, and petty cheating on expense accounts was rampant. Burdened with debt from student loans, Pitts had to ask his father for a loan. He felt humiliated. Pitts later told a psychiatrist that he was" overwhelmed by a sense of rage at the FBI."

One morning he came up with the idea of spying for the KGB. That way he could kill two birds with one stone - solve his money problems and get back at his bosses. He later told a psychiatrist, "I was shoved by the bureaucracy, and I shoved back."

Over the next seven years Pitts worked as a Soviet spy and for his services received \$224,000. When he was finally caught and convicted the judge sentenced him to twenty-seven years in prison. At the sentencing the judge asked him point-blank why he had become a traitor. Earl Pitts replied, "I gave in to an unreasonable anger."

Never allow anger to fester nor cause bitterness. Deal with anger as God prescribes.

ALABAMA'S GOLD STAR FAMILIES MEMORIAL MONUMENT

to be dedicated October 17, 2020

When a loved one loses their life in service to our country, it's hard to know what to say to those left behind.

With the upcoming dedication of Alabama's first Gold Star Families Memorial Monument, the message will be clear: "We will never forget."

The black granite monument, designed by the Hershel "Woody" Williams Medal of Honor Foundation, will be placed at the Huntsville-Madison County Veterans Memorial. It will be dedicated on October 17, 2020.

On its face, the monument will bear the words, "Gold Star Families Memorial Monument, a tribute to Gold Star Families and Relatives." The other side will tell a story through panels depicting scenes unique to Alabama, with the themes Homeland, Family, Patriot and Sacrifice. The centerpiece of the monument is a silhouette representing a Loved One who lost their life serving our country.

The monument is a joint effort of the Hershel "Woody" Williams Medal of Honor Foundation, the Alabama Gold Star Families Memorial Monument Committee, the Huntsville-Madison County Veterans Memorial Foundation, and the City of Huntsville. Its primary sponsors are Mike and Christine Wicks, i3 - Integration Innovation Inc.

WHERE DID THE IDEA FOR GOLD STAR FAMILIES MEMORIAL MONUMENTS START? In 2010, Medal of Honor Recipient Hershel "Woody" Williams formed the Hershel "Woody" Williams Medal of Honor Foundation. Its mission is to honor Gold Star Families by establishing monuments in communities throughout the United States. To date, 62 monuments have been placed, representing 48 states. 77 monuments are in process. This will be the first Gold Star Families Memorial Monument in the State of Alabama.

WHERE DID THE TERM "GOLD STAR FAMILY" COME FROM? During World War I, it was customary for military families to display service flags in their windows, featuring a blue star for every immediate family member serving in the Armed Forces. The star's color would be changed to gold if the family lost a loved one in the war, hence the term, "Gold Star Family."

GOLD STAR MOTHERS AND FAMILIES DAY Since 1936, our nation has recognized the last Sunday of September as Gold Star Mother's Day. In 2011, the law was amended to include the recognition of all Gold Star family members on this day. Gold Star Spouses' Day is April 5.

HOW MANY GOLD STAR FAMILIES ARE IN ALABAMA? The exact number is difficult to calculate because the government does not keep official records on Gold Star families. However, since World War II, Alabama has been home to almost 10,000 servicemembers who lost their lives serving our country. It is reasonable to assume that today there are more than 6,000 Gold Star family members living in Alabama.

WHAT CAN WE DO TO SUPPORT GOLD STAR FAMILIES IN OUR COMMUNITY? Remember that our fallen military personnel were real people whose lives are to be celebrated. Ask family members about their loved one, what was his or her name, what were they like, what were their goals, interests and passions. The Huntsville-Madison County Veterans Memorial was dedicated on November 11, 2011, to pay tribute to all veterans and educate the public about local military history and the cost of freedom.

- 5. Chapter savings account activity was limited to interest.
- 6. The Chapter Operating Funds contains \$1403.07 in reserved funds donated by various VSOs in support of the 2019 RAD Luncheon for the Retirees. This is money unused from 2019 donations and will be applied to the 2020 RAD luncheon or similar event.

needs to be stability, Orr said.

"We've had a series of AOC directors because new chief justices have come and gone, every six years, and they bring their own director with them," Orr said this week. "And that's created a revolving door, as far as the chief administrator of the court system.

"Putting that responsibility with the Supreme Court as a whole, in coordination with the chief justice, should provide more continuity."

If approved, the amendment would also:

- Provide that county district courts do not have to hold city court in a city with a population of less than 1,000
- Increases from nine to 11 the total membership of the Judicial Inquiry Commission, which evaluates ethics complaints against judges, and determines who appoints each member
- Allow the governor, rather than the lieutenant governor, to appoint a member of the Court of the Judiciary, which hears complaints filed by the Judicial Inquiry Commission
- Prevent a judge from being automatically disqualified from holding office simply because a complaint was filed with the Judiciary Inquiry Commission
- Provides that a judge can be removed from office only by the Court of the Judiciary. Currently, the Legislature can impeach judges

Amendment 3

Amendment 3 is also court related. If approved, it would extend the time appointed circuit and district court judges could fill a vacancy before facing election. Under current law, district and circuit judges appointed by the governor serve an initial term of one year or the remainder of the original term, whichever is longer. This amendment would change that initial term of the appointed judge to at least two years before they must run for election.

Amendment 4

Proposed Amendment 4 would reorganize Alabama's notoriously long constitution and remove outdated and racist language.

The Constitution still has references to separate schools for white and "colored children" and laws against marriages between "any white person and a negro". Similar ballot referendums failed in 2012 and 2004.

Amendments 5 and 6

Amendments 5 and 6 are specific only to Franklin and Lauderdale counties, respectively. But because the supporting legislation to specify that church members in those counties can use deadly force if they feel threatened in their places of worship was voted against by one House member, they now go on the statewide ballot.

On the COLA front: The August 2020 Consumer Price Index (CPI) is 253.597, 1.4% above the FY 2020 CPI baseline.

Two deal with Alabama issues, the others include Military Health Care, Veteran Bills signed into law recently, the Veterans Affairs Accountability Office, how a pilot perform against an artificial intelligence algorithm, and who will move to Space Force.

Absentee Voting Instructions

Voting is a civic duty we should take seriously. If you are concerned that voting in person will expose you to COVID-19, rather than not vote, use absentee voting. In Madison County, it's safe, secure, and can be done in person or online and via the USPS. The Madison County Absentee Ballot Office opened 9 September 2020 for voters who want to apply for or submit their absentee ballots in person and anyone who needs help during the absentee ballot voting process. The office is on the first floor of the Madison County Courthouse (100 Northside Square, Huntsville, AL, 35801) open every weekday from 8:30 A.M. to 4:30 P.M. The Madison County Circuit Clerk and Absentee Election Manager is Debra Kizer. Her telephone number is 256-532-3684. When entering the courthouse, you must wear a mask, social distance, and try to bring your own pen.

Voting absentee is usually legal only for people who will be out of the county on election day, are ill or disabled, are taking care of someone or working election day, or are in jail for a crime that still allows them to vote. But this year, Alabama Secretary of State John Merrill has added the COVID pandemic as a legal reason for any registered voter to vote absentee.

All that voter has to do is check the box "is ill or has a physical disability" on the absentee ballot application's list of reasons for wanting to vote absentee. Don't worry if you're not really ill or disabled, officials say. You're not lying on an official document, according to Merrill's order. You are legitimately concerned about becoming ill because of COVID. That's enough this year.

How do I register to vote?

You can register online, by mail or in person. If you have a valid Alabama driver's license or a non-driver's identification card you can register online at the secretary of state's website. If you don't have either, you can download a registration application from the website and mail it to your county board of registrars. The deadline to register for the November general election is October 19th.

How can I get an absentee ballot? Are there important deadlines?

First, Download an absentee ballot application to request the ballot or contact your county absentee election manager. The absentee ballot application must be received by Oct. 29 for the November general election. You can fill out the ballot request online and you need to send a copy (front and back) of a state issued ID such as a driver's license. If your application is approved, the absentee election manager will mail you a ballot. Your completed ballot must be postmarked by November 2nd and received by noon on November 3rd. If hand delivered to your county absentee election manager, it must arrive by 5 P.M. on November 2nd. Only one application can be mailed in each envelope so a spouse must send a separate request. But don't wait. Get your ballot in now, especially if mailing it, to ensure it's delivered in time.

Once you get your ballot, read the instructions first and then follow them carefully. Unless the courts rule otherwise, voters need two witnesses or a notary to sign an affidavit (sworn statement) that must be mailed along with the absentee ballot. Spouses can sign for each other, but you need a second witness. Most banks can provide free notary services if you have an account via the drive through window.

What form of identification do I need to vote? You'll need photo ID, such as a valid Alabama driver's license, non-driver ID, or U.S. passport — a full list of acceptable IDs is on the secretary of state's website.

NOTE: A lawsuit against the state, which is winding its way through the courts, accuses Alabama election officials of failing to take adequate steps to protect the fundamental right to vote during the pandemic. The plaintiffs want the state to eliminate the witness signature requirements and the voter's obligation to provide a photocopy of an acceptable ID.

How do I know my absentee ballot is secure?

In addition to the mailing envelope, the absentee ballot is enclosed within a secrecy envelope and an affidavit envelope. Once the ballot is received, election officials will put it in a safe and secure location until Election Day. In the presence of any poll watchers, poll workers will examine the affidavits on Election Day. The secrecy envelopes containing the actual ballots are set aside to protect the identity of the voters. The ballots are later fed into a tabulating machine.

Suicide Prevention Resources: Take Care of Yourself and Each Other

Globally, people are facing challenges caused by COVID-19. The pandemic may cause anxiety and stress. These feelings may feel stronger with less social interaction. Feeling stressed, overwhelmed, or lonely might increase the risk for suicide for some people. It's important to tend to your mental health and find ways to cope.

There are many resources to help you. These include, but are not limited to, TRICARE mental health services.

Are you or someone you know having thoughts of suicide? Call the Military Crisis Line for free, confidential support 24/7 at 1-800-273-TALK (1-800-273-8255), option 1. You can also send a text to 838255, or start an online chat. If you think you have a medical health emergency, call 911 or your local emergency number, or go to the nearest emergency room

Everyone can play a role in preventing suicide. The Defense Suicide Prevention Office and National Suicide Prevention Lifeline can help you learn about the risk factors and warning signs. Learning this information may help you determine if a loved one is at risk and needs help.

Some risk factors for suicide may include:

- Mental disorders
- Alcohol and other substance use disorders

- Job or financial loss
- Loss of relationship
- Lack of social support and sense of isolation

Some warning signs that may indicate a risk of suicide include:

- Talking about suicide or making a plan for suicide
- Withdrawing from family, friends, or unit
- Expressing feelings of hopelessness, helplessness, or worthlessness
- Sudden changes in mood or personality
- Excessive use of alcohol or drugs

If you feel these warning signs or see them in another person, you should seek help. During the pandemic, you can still reach out for help safely. If you're a service member, veteran, or family member, you may seek help through your primary care manager, chaplain, Military Family Life Counselors, or Military OneSource. Depending on your needs and military status, you can also find support through the Real Warriors Campaign, Make the Connection, and inTransition.

"TRICARE offers mental health care services for beneficiaries coping with excessive depression, grief, and people who might have thoughts of suicide," said Dr. Krystyna Bienia, a clinical psychologist and senior policy analyst at the Defense Health Agency. "You may even be able to get help through telemedicine services from your own home."

Getting mental health treatment as well as <u>learning coping skills</u>, may help reduce the risk of suicide. As outlined in the <u>TRICARE Mental Health and Substance Use Disorder Services Fact</u> <u>Sheet</u>, TRICARE covers many mental health services. These include:

- Individual and family psychotherapy
- Intensive outpatient treatment
- Substance use disorder treatment
- Partial hospitalization programs
- Inpatient treatment

You may need a referral or pre-authorization for some mental health services. However, most office-based outpatient mental health services don't require you to get a referral or authorization. If you're an active duty service member, you do need to get a referral for all services.

During Suicide Prevention Month, take actions to help yourself and others who may be feeling stress due to the COVID-19 pandemic. Learn more about suicide prevention resources. If you think you or someone you know should seek mental health services, get help. Take care of yourself and others and take command of your health.
